A. SPECIAL TOPICS: (Items requiring expanded discussion)

1. Conditional Use Permit Review

Town District: Forest Reserve

Applicant: Donald Blake for Garret Hirschak and Beth Salvas

Project: Construction of a 1,208 sf addition

Location: 50 Route 12, Elmore, VT

Notes: Donald Blake reviewed the project for the DRB on behalf of Garret Hirschak and Beth Salvas. Plans, elevations and a review of the addition were shared with the group.

Discussion: A screened porch addition is proposed with conditioned space below. The elevation of the project is ~1,210 in the Forest Reserve District. The height of the new structure will be ~28 feet, under the maximum height for the district.

No clearing of trees is expected for this project. Silt fencing will be installed to contain excavated materials and reduce/eliminate runoff issues. The addition space does not include a bedroom or bathroom (bedroom not permitted). Any added exterior lighting will be downlighting and no flood lighting will be added.

Motion: P. Rousselle mentioned that the Board approve the conditional use permit for the project as described. The addition may not be used as a bedroom. The total footprint approved is as described in the documents presented with the permit application (~1,208 sqft.). Motion seconded by J. Kennedy.

Location: 279 Nelson Rd. in Elmore
