# Charging Station Update:

 The EV charging station grant application was submitted to the state. The staff of the Lamoille County Planning Commission provided extensive assistance in preparing the grant application. There was a great deal of interest from Vermont municipalities for the program; \$2.4 million in funding requests were submitted for the \$400,000 in available funds. Awards for this highly competitive program will be made in July.

## Update on Cell Service:

 Had an email from someone from the state who is working on the FirstNet program and it was another dead end. It appears there is very little motivation from cell phone companies to expand cell phone coverage in Vermont.
