- Town plan review

 - Milfoil project went very well this summer. There were over 1200 boat inspections this summer.
- Update on broadband
 - Discussion of VT State Parks wanting to upgrade cell/internet connectivity at Elmore State Park – there has been no update from Seth on this
 - Seems like there are a lot of interest, but no real confidence that anything will happen.
 - Maybe an email alert to ask if there is anyone interest in joining a task force (have Sharon send out an email?). Hans will reach out to Bob Burley to see if he thinks this is a good idea.
- Elmore Community Trust
 - Group of folks that Kate is a part of that is looking into forming a non-profit that will buy the Elmore Store and lease it to an operator. This process will be benefited by the Village Center Designation.
