A. SPECIAL TOPICS: (Items requiring expanded discussion)

1. Elmore Zoning Bylaws -

- a. Select Board agreed to make minor revisions to existing EPC zoning ordinance and accelerate public hearings for approval to insure local permitting of Shoreline Districts
- b. Minor revisions will focus on Rural West above 1000' MSL, Rural East and remote Shoreline districts to better reflect parcel sizes and align with town plan.
- **B. NEW ITEMS:** (Schedule w/Select Board, min. 1 wk. prior to meeting)
 - 1. LCPC has advised that Elmore is on a list for VYCC work on Eagle Ledge. This work is not in town budget and no work plan or project description currently exists. Elmore and Worcester are experiencing significant increases and damages from "off road" use. This will likely become an ANR and Water Quality issue in the future.

C. <u>CONTINUING ACTIVE ITEMS:</u> (Update status, by item, by DRI)

- 1. Road Commissioner Update LaCasse
 - a. 127 hours of grading in past month
 - b. All winter and mud season material reserves were expended; 1356 yds. of gravel used for spring repairs.
 - c. Equipment transition to summer configuration completed
 - d. GREEN UP DAY was very poorly coordinated by County
 - i. Approx. 10 day notice of significant changes gave little time for Elmore Coordinator and Road Crew to prepare.
 - ii. Fees increased for tires added \$190 expense this year
 - iii. Fees appear Lamoille Cty specific Hardwick & Wolcott appear to have no tire fees.
 - 1. NOTE: BDS, the Maine Tire Recycler, picks up lots of >1000 tires free, thus local fees appear to be revenue for Lamoille Waste District.
 - iv. Tire disposal was not coordinated with waste management facilities Only Stowe accepted tires, not Morrisville, not Johnson.
 - v. The State no longer picks up tires along State Highways
 - vi. NOTE: 2016 VT Waste Laws will require sorting of recyclables AND garbage significant and undefined additional burdens and costs to town and residents.
