A. Meeting Minutes Approval:

1. The minutes of the June 13, 2018 Select Board Meeting were approved.

B. Special Topics:

1. **DISCUSSION**: Municipal Highway & Storm water Mitigation Program

Notes: This program is intended for fairly large projects and there are federal requirements in place plus a 20% local match. The Deadline for filing is July 13, 2018. The only project that makes sense for Elmore would be the possible design/construction of a salt/sand shed.

This program was appropriated for two fiscal years, FY19 being the second. There is no funding guaranteed after FY19 through the Municipal Highway program. So if the Town is seeking construction funding this may be the year to apply.

A feasibility/scoping study is very likely to be funded. It would provide a lot of useful information for applying for funding in the future. The Transportation Alternatives program will be available in the future though it is limited to \$300K of federal funds. After FY19, if this program is no longer, the Town would likely pursue Transportation Alternatives funds for construction but there may be other options out there as well.

The estimated total study cost is approximately \$20-40k with 20% local contribution which can be Town volunteer and staff time and/or a small contribution to the direct cost of the consultant and LCPC as the project manager. LCPC will charge about 20% of the study cost to be the manager for Federal Highway compliance which is included in the estimated cost of the study.

The grant would pay for engineering. Scoping studies are eligible to review alternatives and determine the preferred concept. Construction funds would be sought in a later fiscal year.

The Select Board unamously decided to submit the application for the grant. If it is approved, another discussion will be had prior to proceeding with any design work.

C. NEW ITEMS:

1. **DISCUSSION**: Elmore Fire Department Building, repair update and go-forward maintenance and support plan.

Notes: Robb Wills presented a progress report for the repair work being performed at the Fire Department Building. SE Martin is approximately 85% complete with the repairs. Brent Hasking participated in a discussion of sharing the cost with the Town of Elmore and the Fire Department. Development of an agreement between the Town of Elmore and the Fire Department was also discussed.

2. **DISCUSSION**: Cross Road; Question of Town responsibility on CL4 roadway. Note: A portion of Cross Road, beginning at the intersection of VT Rt. 12 and extending east-southeast from Rt. 12 approximately 0.35 miles, was reclassified to a Class 4 road in 2012. Background provided at meeting from 11/29/2012 review.

Notes: Sonny Hill requested work to be performed on his Class 4 Road. The Select Board agreed to review the Town's responsibility for maintaining Class 4 roads and get back to him.

1. **UPDATE**: Road Commissioner's Report – Lacasse

2. **UPDATE**: Efficiency Vermont – Street light replacement program. DeVore

Notes: Efficiency Vermont is waiting on Morrisville Power and Light to provide them with an inventory of the existing lights.

Notes: The Plan is 90% complete and has been submitted to the Vermont State Archives & Records Administration for review and comment.

Susan Rousselle will support reviewing files housed in storage and digitize to plan specs. The possible purchase / rental of a high speed scanner was discussed and will be decided at a future SB meeting.

The planning commission is also continuing to work on the plan to provide access to Elmore State park for Elmore Residents/Homeowners for the 2019 season. They are trying to get the best price and working on a plan for identification.
