#### A. Meeting Minutes Approval:

1. The minutes of the July 11, 2018 Select Board Meeting were approved.

#### B. NEW ITEMS:

1. **DISCUSSION**: Town e-mail and digital document retention server capacity (K. Shaw)

Notes: The web hosting and domain name are currently through Go-Daddy at a cost of approximately \$150.00/year. In order to have a system that will allow for retention of emails and allow for storage in the cloud, Ken has looked at a couple of potential options (see attached). In order to make the transition to a new system go smoothly, the Select Board decided to solicit proposals from a minimum of 3 IT Support Companies. The Town currently does not have a contract for these services.

G. Schwartz to write an RFP and distribute to the Select Board for review. Main items to be included in the RFP are retention capabilities, email, backup, servicing of equipment and the evaluation of the existing system.

**Notes:** The Town currently does not have a contract for fuel supply (propane and oil) Robb Wills recently received pricing from Fred's and Bourne's. Rob will continue to research pricing and will present options at the next Select Board Meeting for Board approval.

RE: Speed limit reduction request, VT 12 Elmore

Dear Ms. Draper:

This letter is in response to your November 9, 2017 request to reduce the speed limit on VT 12 in Elmore from the cemetery to State Park Rd.

At its May 15, 2018 meeting, the Vermont Traffic Committee voted to retain the existing speed limits. As stated in my April 23, 2018 letter to you, the Traffic Operations section will install a brown parking symbol with a "boat access" plaque, and arrows pointing to southerly intersection with Camp Rd, and upgrade the first 35 mph sign in the southbound direction to a larger more visible sign.

If the town would like to increase compliance with the existing 35 mph speed limit zone, radar speed feedback signs (RSFS) are fairly effective at a far lower cost than full time law enforcement. The town could consider either using speed carts, or could install permanently mounted RSFS at existing speed limit sign locations under a VTrans permit to work in the state highway right of way. RE: Speed limit reduction request, VT 12 Elmore

Dear Ms. Draper:

This letter is in response to your November 9, 2017 request to reduce the speed limit on VT 12 in Elmore from the cemetery to State Park Rd. We have conducted an engineering study. Multiple speed studies were done. Within the 50 mph zone the 85<sup>th</sup> percentile speed of free flowing traffic was 55-56 mph. Within the village 35 mph speed zone the 85<sup>th</sup> percentile speed of free flowing traffic was 40-47 mph.

The 1.8 mile study area is considered a high crash location (HCL) due to the number of crashes in the past 5 years, although half of the crashes were considered "non-reportable" (< \$3,000 dollars worth of damage). There was only one crash reported in the vicinity of the southerly intersection of VT 12 and Camp Road, a single vehicle crash where the driver was traveling "too fast for conditions" in winter conditions.

We do not recommend a reduction in the speed limit at this time. We will install a brown parking symbol with a "boat access" plaque, and arrows pointing to southerly intersection with Camp Rd. Also, the first 35 mph sign in the southbound direction is not upsized per VTrans standard. The sign will be replaced with an upsized sign. We will forward this recommendation to the Vermont Traffic Committee, who makes the final decision. This topic will be on the agenda of the next Traffic Committee meeting on Tuesday, May 15, 2018 at 1:00 pm in the VTrans Board Room on the 5th floor of the National Life Building in Montpelier. Please attend if you wish to present testimony on behalf of the town. If you or members of the public are unable to attend but would still like to participate, please let me know and we can arrange a telephone connection. We encourage the town to notify local stakeholders of the opportunity to participate in this meeting.
