To date two proposals have been received regarding engineering services for site development plans. In order to receive a third proposal for this work, M. Lacasse will forward the contact information of another company that has done work for other municipalities to G. Schwartz. Once this contact information is received G. Schwartz will make contact to acquire the third proposal.

b. UPDATE: Clerks Office Maintenance

WORK COMPLETED:

- 1. Dug up large rocks in road way of Mt road, Bliss Hill and Leahy so grader blade would not hit them,
- 2. Fix potholes in asphalt on Beach road and Pond road.
- 3. Repaired and painted picnic tables in town park.
- 4. Grade Brown Hill to Woodbury line. Had to water the road before starting. Used a full load of chloride to hold it in place, 1000 gallons.
- 5. Started grant work on Gates Farm road.

EQUIPEMENT:

- 1. All is in summer mode.
- 2. Rented excavator for the month of June and July to do grant work.

UPCOMING ISSUES:

1. Ice house structure grant has been awarded, can not start anything until July 1, work may not get started until spring of 2022. Will need reserve funds to cover the cost \$200,000.00.
