The minutes of the February 9, 2022, February 22, 2022 and February 24, 2022 Select Board Meetings were approved

1. SPECIAL TOPICS

a. DISCUSSION: Welcome new board member; appointment of Town officers; nomination of board chair, vice-chair, clerk

Notes: The attached list of appointed officials were approved by the Select Board. In addition, Caroline DeVore was elected Select Board Chair, Warren West - Select Board Chair backup and Glenn Schwartz- Select Board Clerk. The following items were also discussed/approved by the Board;

- Warren West was welcomed as the new Select Board member
- Michelle Weppler was recognized for her many years of service to the Town
- Michel LaCasse was appointed as Town Grand Juror to fill a vacant position
- Sharron Draper was appointed as Town Delinquent Tax Collector
- Sandra Lacasse was appointed as assistant Town Delinquent Tax Collector
- Sandra Lacasse was appointed as assistant Town Clerk
- Total compensation of \$2,000.00 to be shared for the Town Delinquent Tax Collectors
- The remainder of the 8% fee for Town Delinquent Tax Collections will be returned to the Town
- The replacement of K. Rose as the Towns Health Office was discussed. G. Schwartz to seek a qualified person to take this position.
- b. UPDATE: King Road land survey

Notes: C. Devore stated that she contacted the Town's attorney regarding this issue. The attorney stated that the location of the roadway as confirmed by survey and on file at the Towns office shall be the location of the road.

2. ACTIVE ITEMS

a. UPDATE: Elmore highway maintenance facility (passed); Land next steps; DRB update, formation of committee

Notes: Seth Jenson from the LCPC stated that he has had conversations with the USDA regarding the bond amount to construct the Maintenance Facility. The bond can be separated into two (2) phases. Phase 1 would be financed through the Vermont bond bank at a similar rate to that of the USDA. This phase would include land purchase, final design and permitting costs. Seth will research to see if the Sitework can be included in the Phase 1 financing. Phase 2 which will

consist of the actual construction of the facility would be financed through the USDA. Final design and architectural drawings will be necessary for application of the loan. Seth stated that this should be done as soon as possible to avoid possible interest rate increases. The Select Board will attend the DRB Meeting on March 17 to discuss the possibility of reducing the amount of land to be purchased. G. Schwartz presented a drawing (attached) created by Cross Consulting Engineers that could reduce the land purchase to 10 acres. Caroline will contact Turner Keith on 3/18 to discuss the land purchase as discussed at the DRB Meeting. The purchase documents would then be developed by legal counsel the following week. Seth Jenson would then advise as to the closing date for the transaction. Warren West will setup the advisory committee and will be looking for 4-5 volunteers. G. Schwartz to create a flow plan for the phased work and a budget for the Sitework that will be provided to Seth. If it is determined by the DRB that we can purchase less than 18 acres the Town will ask that a right of first refusal be incorporated into the land agreement for the remaining acreage.

b. UPDATE: Elmore School petition (Did not pass)

The location should also be incorporated into the deed of the property. The Town Heath officer is currently an open position that we are hoping to fill ASAP.

d. DISCUSSION: Additional Office Computers

Work to Date:

- 1. Plow and sand as needed.
- 2. Dealt with multiple high wind events, lucky damage was minimal.
- 3. Lots of rain water had a difficult time getting into ditches with snow banks so frozen.
- 4. Hired Manosh to thaw out a frozen culvert on East Elmore road, 24 inch by 40 foot pipe frozen entire length. Water flowed over the roadway creating a mess.
- 5. Started punching holes and pushing back snow banks with equipment.
- 6. Smoothing up roads with grader.

Equipment:

1. Working well. Changed several hydraulic hoses on the loader.


Employees:
