a. **DISCUSSION:** Appointment of alternate DRB members; meet candidates (1 year terms)

b. APPROVAL: Appointment of assistant Clerk as alt signatory

- Sandra LaCasse was appointed as alternate signatory for all checks except payroll checks of related parties

#### 2. ACTIVE ITEMS

a. UPDATE: Elmore highway maintenance facility; working group; land; funding, site work, etc (update)

Notes: The proposal provided by Cross Consulting Engineers was reviewed

- Peter Garceau attended via zoom to answer questions raised by G. Schwartz and W. West.
- All but one of the questions and comments were answered and will be incorporated into a revised proposal to be sent over tomorrow.
- The final issue to be resolved is the amount of E & O insurance that will be provided. The Board voted on a minimum of \$1,000,000.00 instead of the \$50,000.00 shown on the proposal
- A meeting was setup between P. Garceau and G. Schwartz for 11:15 tomorrow morning to finalize the proposal.
- A motion was made by C. DeVore to allow G. Schwartz to sign the proposal once the changes have been made. All of the members voted in favor.
- The purchase of sale agreement for the 18 acres was signed by C. DeVore and forwarded to the Keith attorney for signature. The closure date will be on or before June 30, 2022.
- S. Draper is in the process of procuring pricing from at least two firms to perform a Town Audit.
- W. West stated that the next available bond letting will be in December.
